



DIBROM® CONCENTRATE and TRUMPET® EC 2022 NATIONAL DRUM RETURN PROGRAM

Through our **AMGUARD Environmental Technologies** product stewardship program, **Container Services Network (CSN)** manages all logistics for the pick-up and return of your empty **DIBROM® CONCENTRATE** and **TRUMPET® EC** drums. This is a premium service provided at no additional cost to you. The following instructions are provided to assist you in this process. As always, we thank you for your cooperation and your trust in AMGUARD Environmental Technologies products.

What's new?

The current logistics market is encouraging smaller, reconfigurable loads. This aides in carrier routing efficiencies during times of limited drivers. Please confirm the following when scheduling your drum return:

1. All drums must be "empty" with both bung openings sealed.
2. A minimum quantity of 8 drums is required for pick up. 48 is optimal.
3. Returns of 8-10 drums may be prepared and loaded individually.
4. Returns of 11 or more drums should all be palletized in sets of 8.
5. Stack two pallets of 4 drums each and secure together using stretch wrap.



When is a drum considered empty?

Drums are filled according to weight ensuring a full 30 gallons of product can be dispensed. Drums weighing up to 29 lbs. or a pallet of 4 drums weighing up to 160 lbs. is defined as empty. All drums are individually weighed upon return. Please only submit empty Dibrom or Trumpet drums for pick-up under this program. You are now ready to complete your return!

Step #1

Send an email to logistics@containerservicesnetwork.com. Include the quantity of drums being returned, a detailed pick-up address, hours of operation for receiving trucks and a mobile contact number where the driver can reach you.

Step #2

CSN responds to all drum return emails within 48 hours. Mike or a member of his team will update you by email and include a copy of your Bill of Lading. Once received, please review all details on the BOL for accuracy.

Step #3

Finally, PRINT the BOL and have it available for the driver upon arrival. The availability of preferred carriers varies daily. We ask that you remain flexible during this stage of logistics and feel free to contact us with any questions or concerns.
