Preconstruction subterranean termite treatment control

Effective preconstruction subterranean termite control, including Formosan termites, requires an unbroken vertical and/or horizontal chemical barrier between wood in the structure and the termite colonies in the soil.

Post-construction treatments

Post-construction applications can be made by sub-slab injection, trenching and rodding into the trench, or trenching using a low-pressure spray not exceeding 25 psi at the nozzle.

Posts, poles, and other constructions

Application may be made to create a chemical barrier in the soil around wooden constructions, such as signs and landscape ornamentation, by applying a 0.50%-1.0% emulsion.

Treatment of wood in place for control of termites and wood-infesting beetles

This product may be used for treating infested wood in place. It can be applied with a crevice tool, coarse fan spray or by injection.

Termites above ground

For control of termites, subterranean aerial colonies, Formosan aerial colonies, or drywood termites in localized areas of infested wood in structures, apply 0.25%-0.50% emulsion to voids and galleries in damaged wood and in spaces between wooden members of a structure, and between wood and foundations where wood is vulnerable.



Control of wood-infesting beetles

To control wood-infesting insects such as powderpost beetles (Lyctidae), false powderpost beetles* (Bostrichidae), deathwatch beetles* (Anobiidae), old house borers (Cerambycidae), and ambrosia beetles* (Scolytidae) in homes and other structures, apply as an emulsion containing 0.50% PRELUDE termiticide/insecticide.
